## Financial Aid Application and Agreement

**All applications will be considered based on the availability of funding for the program.**

To apply for Hyde Park Suzuki Institute's Financial Aid Program, please complete the *entire* application and attach a copy of your most recently filed federal income tax form (1040, 1040A, 1040EZ). It is not necessary to attach other schedules and forms submitted with your 1040 (e.g. Schedule A, Form 2106, et. al.). All information submitted is confidential. Awards are based on need. The amount of financial aid is determined by a sliding scale, which takes into account household income and number of dependents. Registration forms for all students and all classes must be submitted to the Hyde Park Suzuki Institute, hereafter referred to as "HPSI," along with the registration fee and all required tuition deposits. Applying for financial aid does not exempt the applicant from registration fees and deposits. Student must be high school senior or below.

Please apply as early as possible. Return your completed materials to HPSI. Original applications must be submitted by mail or hand-delivered to HPSI by deadline. We will not accept applications by fax. If you have any questions or would like assistance completing this application, please call HPSI 773.643.1388.

### How to Apply:

1. Complete all sections of the Financial Aid Application, including the Letter of Agreement.
2. Attach a copy of your most-recently filed federal income tax form (1040, 1040A, 1040EZ). If you do not file a federal income tax form, please submit copies of other verification of income and/or support.
3. Call HPSI for help completing the application.
4. Only completed and signed applications will be considered.
5. Applications from families with an outstanding account balance will not be considered until the balance is paid in full.

### Award:

1. Reduced tuition based on a sliding scale for lessons, classes or ensembles.
2. Award applies to one calendar year only; one child per family.
3. Financial aid awards will be reduced each year of application.

### Award Obligations:

1. Parent, Guardian or family member of the student must register and serve as a volunteer to help HPSI in any way needed.
2. Consistent practice and preparation for lessons, classes and/or ensembles.
3. Positive evaluations from teachers.
4. Any balance of tuition not covered by financial aid must be paid in full by the deadline specified by HPSI
5. Consistent attendance at lessons, classes and/or ensembles.
6. Student must perform in recitals and performances.
